## PRIVACY POLICY 06/09/2019

We take your privacy very seriously and understand that you care about how your personal information is used and shared. Please read the following to learn more about how we collect, store, use and disclose information about you when you interact with us, in any manner, via our website and/or through the provision of our services.

### Information

When using our website, we collect two types of information from site users; personal data that you fill in yourself when you subscribe to the newsletter or fill in our contact form (including, where relevant, names, e-mail addresses, contact telephone number and company name) and statistical data (e.g. site visits, web browser type, operating system type and visitor geography).

### Personal Data

This is only captured when provided by you, for example, when you subscribe for updates, contact us through our website, or engage us to provide services.

If you subscribe for updates, our website stores your email address in a database and MailChimp. Your mail addresses will only be used to periodically send you emails containing news, information about our services or industry information which we feel is relevant to you. ### Statistical Data

Whenever you visit our website, we collect limited statistical data using cookies and other similar technologies which may involve saving cookies to your computer. This is purely for the purposes of website analytics. Our site uses cookies from Google to allow us to track users movements from Google Analytics to help make sure the site is meeting the needs of its users and to help us make improvements. In continuing to use this website, you agree to have these cookies installed in your browser.

Google Analytics stores information like:

- the pages you visit on our site
- how long you spend on each page
- how you got to the site
- what you click on while you're visiting the site
- the type of web browser you use,
- the type of operating system your computer runs
- your geographical location
